Terms and Conditions for the Inclusion Services LLC ServiceNow World Forum 2024 Sweepstakes

1. Sponsor

The sweepstakes ("Sweepstakes") is sponsored by Inclusion Services LLC ("Sponsor"), with headquarters located at 3625 10th St. N, Arlington, Virginia, USA.

2. Eligibility

The Sweepstakes is open only to legal residents of the United States who are 18 years of age or older and are employed in the U.S. at the time of entry. Participation is limited to attendees of the ServiceNow World Forum 2024 event in Dallas, Texas. Employees, officers, and directors of Sponsor, as well as their immediate family members and household members, are not eligible to participate.

3. Agreement to Official Rules
